Beach Cities Robotics Consent, Release, Hold Harmless and Authorization to Reproduce Physical Likeness

This is a Consent and Release of Rights in favor of Beach Cities Robotics ("BCR"), and their mentors, directors, officers, and assigns, as well as entities designated and approved to assist BCR in managing, contracting, sponsoring, hosting, conducting, evaluating or publicizing BCR's programs ("BCR's Cooperating Entities"). I HEREBY RELEASE BCR and BCR's Cooperating Entities and their respective successors, affiliates, licensees, and assigns from all claims, demands, liabilities, damages, costs and expenses, attorneys' fees, other professional fees and expenses and any claims including, without limitation, claims for compensation, defamation, or invasion of privacy, or other infringements or violations of personal or property rights of any sort whatsoever that I may now or hereafter have against BCR and BCR's Cooperating Entities arising in connections with my participation in any BCR activity.

In the event I should sustain injuries or illness while involved in a BCR activity, I hereby authorize BCR and BCR's Cooperating Entities to administer, or cause to be administered, such first aid or other treatment and medication I may bring as may be necessary under the circumstances, to include treatment by a physician or hospital of BCR's or BCR's Cooperating Entities' choice.

Severability: I further expressly agree that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in the activities made possible by BCR. I hereby assert that my participation is voluntary and that I knowingly assume all such risks. I also agree to INDEMNIFY AND HOLD HARMLESS Beach Cities Robotics and BCR's Cooperating Entities from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorneys' fees brought as a result of my involvement in BCR. This Release constitutes the entire agreement among the parties hereto with respect to the subject matter of this Release and supersedes any and all previous agreements among the parties, whether written or oral, with respect to such subject matter.
